- Pat Burrows for, amongst her many activities, organising early Sunday morning Bird Watching;
- Last but by no means least Penny Drake-Brockman for keeping an eye on everything, particularly the birds, inspiring all of us and reminding that life is for living!

GEG Member, Louise Duff has successfully taken on the role of RiverCare coordinator from Penny and also attended Committee and other meetings when needed. Despite floods we

have a whole crop of new trees and understorey in District Park and thereby greatly contributed to one of GEG's greatest legacies. And when Louise was off walking the Camino, GEG Member and all round doer, Carolyn Davies stepped up to keep things going. Members can read more about our year's activities in the portfolio reports submitted for the AGM.

It is pleasing that, whilst Members come and go our total membership remains at around 120. I extend grateful thanks to Members who have hosted Feasts or been involved in some way in our various activities - particularly some who seem to turn up at just about every event.

A couple of times this year we were at the Markets to promote the Group. On each occasion the community response was very positive.

I am happy to acknowledge the support that MidCoast Council gives GEG. From chats with the Mayor, to the expenditure to support KoalaWays and RiverCare. I estimate that each plant that goes in the ground, gets watered and is given a guard and stakes, costs about \$10. So, the landowners that benefit from a a KoalaWays planting get around \$3,000 worth of infrastructure for free. Around 2,000 plants have gone in the ground in 2026. Thanks to Council staff, including the ecologists, managers of parks, nursery managers, even the grass cutters, including - Mat Bell, Caitlin Orr, Anthony Marchment, Kim Gollan and Nic Coleman. It is sad to note that the Seedlings Project on the site of the Gloucester Creatives isn't continuing. This was a major and worthwhile initiative, but it needed the focus of a committed, long term coordinator. It was a success whilst it lasted. Thanks to Gloucester Creatives for making the site available. Special thank you to Marnie Johnston and David Jenkins for organising its establishment. Marnie ran informative and productive workshops. Thank you to the Members who turned up to the building and then the growing of around 2,000 seedlings.

We will soon be undertaking a planting with Gloucester Lions who have their own Nationwide "Green Canopy" and selected us for funding to an amount of \$300. We are hoping to continue this collaboration in 2026 with other projects.

Sorry if I haven't properly acknowledged anyone or any organisation who has contributed this past year to the successes of GEG.

I look forward to 2026, when we will happily continue with the Objects of the GEG – written back in 1991 –

"Promoting public awareness in environmental issues."
