

GLOUCESTER ENVIRONMENT GROUP-PRESIDENT'S REPORT FOR 2022 AGM

We were recently approached by Landcare who want to expand their activities in the Gloucester area. They are not in competition with us, and I am pleased that they want to be more active, particularly working with farmers to preserve and increase native vegetation cover.

Some further activities that I would like to see us get more involved with in the year ahead are:

- Working more closely with Landcare,
- Promoting the regeneration of our riverbanks on private land in co-operation with Local Land Services,
- Lobbying MidCoast Council to expand the areas covered by tree preservation orders and to increase its urban tree planting in Gloucester, and
- Lobbying the state government to improve the laws and regulations relating to the clearing on native vegetation on rural land.
