President's welcome and Report: John Watts

It is 26 months since our last AGM. Because of the annoying Covid virus the Environment Group (GEG) did not hold an AGM in 2020, and so my report is for the period since our last AGM instead of the usual one year. So, your committee was able to cling to power for longer than usual without the need for any messy democratic vote in 2020-which I know sounds like the kind of excuse used by some third world dictator for not going to the polls. But thanks to all the members for not rioting in the streets in protest.

Before writing this report, I re-read Jeff Kite's 2019 President's report and I would like to start by saying that the good things that GEG achieved during the last 2 years was only possible because of the solid foundations laid by Jeff during his six years at the helm. So, thanks again to Jeff for all he achieved as President.

I have been involved with many organisations over the years and sat on a few boards and committees, but I have never had the pleasure of being involved with a group as harmonious and as effective as the GEG committee. Each member of the committee had the same motivation and shared the same vision, which was to work hard for a better environment for the Gloucester area. So, my sincere thanks to all members of the committee for their great work. Being president is a very easy task when there is such a great and supportive committee who do all the hard work.

You will see from the agenda that we will be receiving reports from various committee members who have taken on and run with various tasks, and they will fill you in about all the good things that have been happening with our financial management, bushwalks, Rivercare, Koalaways, Feasts, Media, and plastic free Gloucester. My thanks to all those who will be giving their reports, but my particular thanks to both Janine and Terry for their great work as secretary and Treasurer. Secretary is such an important role to keep the wheels

turning and to keep all members informed about what is happening, and Terry was able to make sure that we did not spend more than we had.

I would like to say something about two matters which are not specifically on the agenda.

Firstly, I would like to mention Minimbah Gardens.

Minimbah Gardens was established some years ago by a few people of vision as a place to acknowledge and celebrate the Aboriginal community of this region.

Last year we were approached by Anna Burley from Bucketts Way Neighbourhood Centre who told us that they had received a Government Grant to carry out some rejuvenation work at Minimbah Gardens. She asked whether GEG would like to be involved in organising and carrying out the work and we jumped at the opportunity, although we were very conscious of the need for extensive consultation with the local Aboriginal community so that we were not seen to be butting in and taking over where we were not wanted. There has been far too much of that over many years. We did consult extensively and made it clear that we were there to listen to any concerns and that what we intended to do was to simply undertake some rejuvenation work with no intention of changing the character of that beautiful place. All throughout we had a good relationship with our local First Nations peoples.

One problem we had was trying to make the conditions of the Government grant fit with the actual work that was needed. We had many enthusiastic volunteers attend the many working bees which were held, and lots was achieved with fences, paths, gardens, and steps being fixed. Many trees and shrubs were planted, and many weeds were removed.

In the end we were not able to spend all the grant money and it was diverted into a tree and shrub planting of a nearby area.

The second issue that I would like to mention relates to our relationship with the Midcoast Council and its several environmental plans. The Council has produced a Biodiversity Strategy; a Greening Strategy; a Manning River Estuary Management Plan and a Vegetation Management Plan. The committee decided that we should make our views known and we held meetings with the Council officers responsible for the reports. It was great to meet with people with such expertise and enthusiasm for improving the environment of the Midcoast area.

We have been lobbying for a long time for the introduction of some kind of Tree Preservation Order to stop the wilful destruction of native trees. The Vegetation Management Plan does introduce some limited protection for parts of Barrington and Gloucester. It does not go nearly far enough but we decided to strongly support it in the hope that it will be strengthened in the future. The Council people explained that politically it might be difficult for more to be achieved with the present Council makeup.

My thanks to Tibor for preparing all the very professionally written submissions that were sent to Council.

The Council has no power to control vegetation management of rural areas and State Government laws are weak and poorly enforced. Part of the Council plans involve using a carrot to encourage better vegetation outcomes in rural areas, and we are starting to play our part as Di will explain when she presents her report.

Our membership numbers continue to grow. It is now well over 80.

Finally, thanks to those who have agreed to be part of the committee for the year ahead. I look forward to working with you.

RiverCare Co-ordinator Report: Penny Drake-Brockman

Owing to the pandemic restrictions last year, no report was submitted for 2020 so this report covers two years.

With the commencement of the Koala Plantings and then the work at Minimbah, the RiverCare sites have received less attention. However, most sites have been checked following the 2021 floods and all except two are in good condition. Below is the current situation.

SITE 1 GUY'S BENCH

Upper level was relatively unaffected by the floods and has been cleared of debris and weeded. Flood removed the huge Fig tree, bank and lower level at the southern end and swept clean the lower mid to north area; Council have now removed the broken white cedar at the southern end. A few sandpaper figs, bottlebrushes, casuarinas, lomandra and water gums have survived on the lower level. Perhaps we should plant a few more water gums on the bank as these survive well. I cleaned out the section we planted in July 2016 for National Tree Planting day, removing debris and cutting broken branches, and a small group of us completed the planting on the eastern end.

SITE 2 THUNDERBOLT'S BRIDGE

This hasn't had any work done on it for two years and is very overgrown. The floods took out mature casuarinas and some of our trees beyond the first gully. A clean up on the section as far as the first gully with more planting of lomandra and a few trees could be done. Ian Jackson would like us to plant on the grassed area above, allowing for easy mowing. Perhaps a Koala project?

SITE 3 MINIMBAH SOUTHERN BANK

This suffered particularly at the northern end near Minimbah garden. David Kirkwood and I have staked trees and cleaned up debris. Two larger trees are too flattened to raise except with a lot of hard work; a Swamp Mahogany and an acacia at the north end have died. Some infill planting and weeding has recently been carried out.

SITE 4 KING GEORGE PARK

The lower level was flooded to above 4 metres with river bank lost and trees damaged. Plastic bread bags were collected in quantity. Weeding has been neglected and I'm trying to get on top of it. A sink hole appeared on the upper level (now filled) and a mature liquid amber tree died. Grey-headed Flying Foxes took up residence at the north end of the boardwalk and stayed about a month.

SITE 5 BILLABONG BANK BEHIND HARDWARE

This site has been neglected and is high in weeds. Some trees are growing well and I suspect more are hidden by the weeds. No work done here for at least 2 years. Weeding / infill planting needed.

SITE 6 BANK EITHER SIDE OF NEW FOOTBRIDGE

This was badly hit by floods with tree trunks banked up against the footbridge. We did some work on the east side of the bridge, clearing and freeing trees from flood debris, and very

few have been lost. Since then Council with Aus Eco workers have carried out a major job laying jute mesh and planting. No work has been done on the west side.

SITE 7 MINIMBAH ABORIGINAL GARDEN

This suffered badly in the floods, particularly around the billabong where serious damage occurred to trees and the new steps. Shrubs and trees were lost on the western side and here Council have cut down all or part of the dead casuarinas and removed heavy flood timber from most of the area although there still remains some in the northwest corner. We cleared debris and rescued trees on the upper level. Our recent planting on the north boundary survived and has been re-staked and mulched; 3 tube stock have since died and need replacing. David K, Tibor and I recently planted lomandra and tree tubes left over from previous stock, to fill in gaps. Mowing and whippersnipping continues to be carried out by Community Service workers from Taree.
